- Syrancot, Bicton Lane, 2 storey side and rear extension, 16/00774/FUL, This will not affect any other property so the decision is-no objections. Land East of Bicton Lane, 15 houses, 15/04035/FUL. Appeal against SC's refusal. *Please note that this is separate to the 14/02239/OUT appeal. Both appeals are for the same houses on the same land but* 5.2 *legally they are separate applications.* The clerk will try to find out the date of the hearing. Also he will write to the inspector to reinforce BPC's strong objections by making the following points; 1, This is not a natural extension to anything, 2, it is unsustainable in the planning sense of the word, 3, it is overdevelopment, even gross overdevelopment, 4, the only access is along Bicton Lane which is already overcrowded especially at school time, 5, it is grade three agricultural land which DEFRA states should be kept as farm land.
- The clerk received a request from SC planning officer Mared Rees for a pre-application comment on the 5.3 owner of Isle View Nursing Home's intention to build a 24 room extension. The clerk suggested to Mared that this seemed somewhat irregular and BPC would be well advised not to make a comment until it has seen the application. BPC agrees with the clerk.
- Bryn Teg, Shepherd's Lane, erection of front porch, 16/00567/FUL, This is a very modest extension and 5.4 BPC has no objections.
- East Grove Farm, 4 stables, 16/00233/FUL, these are on an existing yard and BPC has no objections. 5.5
- The new care home at Uddlington. The sign at the site entrance is now advertising a cafe open to 5.6 the public. This is at odds with the planning application and the number of car parking spaces. The clerk will try to find out what this means.

- Muriel's Little Wood, Safety Report, Standing Agenda Item. Some strimming would improve the 6.2 access but all is safe.

It was pointed out that any maintenance that BPC 6.3 does to Bicton Pool needs to be minuted, then if it is ever necessary for BPC to assert its ownership there will be an audit trail.
